





# INTERNATIONAL MEMORANDUM

#### ECCLESIASTICAL AND INDIGENOUS STANDING crown of judah: international ecclesiastical embassy of yahuah

(COJIEEOY)

Established under Divine Covenant, Indigenous Right, and International Law

# I. INTRODUCTION

We, the spiritual government and sovereign tribal body known as the **Crown of Judah: International Ecclesiastical Embassy of Yahuah (COJIEEOY)**, hereby submit this memorandum to affirm our international standing as a non-territorial, faith-based, and Indigenous – Aboriginal Nation operating under ecclesiastical law and covenantal governance.

This memorandum is made in good faith and serves as official notice to all nations, organizations, and foreign governments of our **spiritual jurisdiction**, **diplomatic authority**, and **internationally protected rights**.

#### II. LEGAL, SPIRITUAL & INDIGENOUS FOUNDATIONS

COJIEEOY derives its authority from:

- The **Torah** and the Everlasting Covenant of Yahuah with the House of Yashar'el and The Kingdom of Yahudah.
- The natural right of Indigenous peoples to self-govern,
- The legal protections afforded by:
  - Vienna Convention on Diplomatic Relations (1961),
  - United Nations Declaration on the Rights of Indigenous Peoples (UNDRIP),
  - International Religious Freedom Act (IRFA U.S. Public Law 105-292),

- o Universal Declaration of Human Rights,
- **Treaty of Hopewell (1786)** and historical tribal instruments.

### III. NATURE AND SCOPE OF OUR GOVERNMENT

#### 1. Non-Territorial Sovereignty

COJIEEOY is a global Indigenous Ecclesiastical Government representing the scattered and reawakening tribes of the ancient Kingdom of Judah. We exercise **non-territorial sovereignty** with full internal self-governance in religious, cultural, and administrative matters.

#### 2. Ecclesiastical Embassy Status

We are not a religious denomination but a **divinely structured government**, with diplomatic outreach, spiritual governance, and international operations.

#### 3. Humanitarian Mission

Our foreign mission includes:

- Advocacy for displaced Israelite descendants,
- Indigenous restoration,
- Ecclesiastical registry and national ID issuance,
- International ministry and peacekeeping.

# IV. CLAIMS AND RECOGNITION

#### We assert the following:

- 1. **Right of Recognition** as an Indigenous government under UNDRIP Article 33 and Article 18.
- 2. **Right to Issue Documentation**, such as diplomatic credentials, ID cards, letters of travel, and ecclesiastical charters.
- 3. **Right to Enter Treaties and Alliances** with other tribal nations, churches, or sovereign groups.
- 4. **Right to Participate in International Forums** as a faith-based NGO and ecclesiastical observer.
- 5. **Right to Refuse Subjection** to secular identification systems, forced mandates, or policies that violate our sacred law.

# V. REQUEST FOR ACKNOWLEDGMENT

We respectfully notify the international community and request:

- 1. Acknowledgment of COJIEEOY as a legitimate ecclesiastical and **Indigenous government** under international law.
- 2. **Permission to observe or participate in international meetings** as a nonmember, faith-based tribal entity.

3. **Guarantees of protection from interference** while carrying out foreign missions, humanitarian outreach, and religious expression.

# VI. PARTNERSHIPS & AFFILIATIONS

COJIEEOY is actively engaged with:

- Allied Tribal States,
- Ecclesiastical, Yashar'elite and Yahudite restoration movements across the Americas and Africa,
- International humanitarian outreach (food sovereignty, refugee support, ancestral land recovery),
- Foreign governments who seek spiritual and cultural reconciliation.

# VII. CLOSING DECLARATION

In the Spirit of Peace, Justice, and Divine Truth,

We, the Crown of Judah Nation, operating through our ecclesiastical embassy, reaffirm our commitment to global cooperation, moral diplomacy, and the restoration of Yahuah's order on Earth.

We walk not in rebellion, but in righteousness.

We submit not to Babylon, but to the covenant.

We seek recognition not for vanity, but for the fulfillment of prophetic destiny.
