CROWN OF JUDAH TRIBAL NATION OF YASHAR'EL

Official Legal and Spiritual Reference Document

I. Introduction

This annex serves as an official reference to the **international, treaty-based, and customary legal instruments** that affirm and protect the **sovereignty, land rights, spiritual customs, and self-determination** of the **Crown of Judah Tribal Nation of Yashar'el** and its governing **Tribal Trust Charter**.

II. United Nations Declaration on the Rights of Indigenous Peoples (UNDRIP)

The following articles of UNDRIP are specifically invoked and incorporated by the Crown of Judah Tribal Nation of Yashar'el:

- **Article 3** – Indigenous peoples have the right to self-determination.
- **Article 4** – The right to autonomy or self-government in matters relating to internal and local affairs.
- **Article 5** – The right to maintain and strengthen distinct legal, social, and political institutions.
- **Article 8** – The right not to be subjected to forced assimilation or destruction of culture.
- **Article 26** – The right to lands, territories, and resources traditionally owned, occupied or used.
- **Article 33** – The right to determine their own identity or membership.
- **Article 36** – The right to maintain relations across borders with other Indigenous peoples.
- **Article 37** – The right to recognition and enforcement of treaties and agreements with States.

III. Applicable Treaties and International Instruments

- **Treaty of Hopewell (1786):** Pre-constitutional recognition of tribal sovereignty and territorial rights.
- **Vienna Convention on Diplomatic Relations (1961):** Legal respect for sovereign and Indigenous diplomatic entities.
- **Hague Trust Convention (1985):** International recognition of transnational trust law and private Indigenous entities.
- **Universal Declaration of Human Rights (1948):**
 - *Article 17(2):* No one shall be arbitrarily deprived of their property.
- **International Covenant on Civil and Political Rights (ICCPR):**
 - *Article 1:* All peoples have the right to self-determination.
- **UN General Assembly Resolution 1514 (1960):**
 - Declaration on the Granting of Independence to Colonial Countries and Peoples.

IV. Lawful and Spiritual Affirmation

These provisions are cited in harmony with the **divine commandments and covenant of Yahuah**, the Elohiym of our ancestors. Our nation's right to exist, govern, and possess the land is not granted by man, but by the Great I Am, as written:

“When the Yahuah divided to the nations their inheritance, when He separated the sons of Adam, He set the bounds of the people according to the number of the children of Yashar'el. For Yahuah's portion is His people; Yashar'el (Jacob) is the lot of His inheritance.”

— *Deuteronomy 32:8–9*
