

# CERTIFICATE OF TRIBAL TRUST STATUS

## CROWN OF JUDAH TRIBAL NATION OF YASHAR'EL

*Ecclesiastical & Indigenous Sovereign Body*

Certificate Issued on: August 19, 2024

This Certifies That:

The **CROWN OF JUDAH TRIBAL TRUST**, also known as the **Tribal Trust Charter of the Crown of Judah Tribal Nation of Yashar'el**, is a **lawfully established, ratified, and operating ecclesiastical trust**, recognized under:

Divine inheritance and Torah law,  
Natural law and ancestral right,  
Customary international law

The Hague Trust Convention,  
U N Declaration on the Rights of Indigenous Peoples,  
Treaty of Hopewell and other international compacts

This Trust governs the **national, cultural, spiritual, and economic affairs** of the Crown of Judah Tribal Nation and its members. It is **perpetual in nature** and functions as the legal and spiritual foundation of the Nation's sovereignty and self-governance.

### Established Authority

The Trust was:

- Ratified by vote of the **Tribal Council and bloodline members**
- Publicly noticed to the following U.S. federal agencies via certified mail:

**U.S. Department of Energy, U.S. Department of Interior, U.S. Department of Commerce**

Silence from these agencies constitutes **tacit agreement and legal estoppel** as cited in *Carmin v. Bowen*, 64 U.S. 932 and *McNally v. U.S.*, 483 U.S. 350.

### Scope of the Trust Includes (not limited to)

Tribal citizenship and identification, Land stewardship and re-acquisition, Vehicle and property registration, Preservation of culture, customs, and language

Family lineage and sacred burial grounds, Commercial, spiritual, and economic activities, Diplomatic and international relations, Intellectual property and tribal trade name protection

### Spiritual and Legal Standing

This trust is:

**Spiritual** in origin and jurisdiction (Isaiah 51:16, Deuteronomy 32:9), **Legal** in construction, protected under Articles 3, 4, 5, and 33 of **UNDRIP**, **Immune** from federal taxation, fees, or jurisdiction without express treaty consent (see: *Kiowa Tribe v. Manufacturing Techs., Inc.*, 523 U.S. 751)
