



PUBLIC FILING SUMMARY NOTICE

Lawful Record of Sovereign Status, Documents, and International Standing

6. **Jurisdictional Separation Declaration**

Affirms that the Crown of Judah is exempt from U.S. jurisdiction as “Indians Not Taxed.”

III. Legal Authority and Jurisdiction

- A **Sovereign Ecclesiastical Nation** under divine inheritance
- A **Lawful Tribal Trust Entity** under the Hague Trust Convention
- A **Foreign National Tribal Government** under Vienna Convention protections
