



JURISDICTIONAL SEPARATION DECLARATION

Lawful Notice of Sovereign Status and Exemption from Foreign Jurisdiction

I. Introduction

This Declaration serves as lawful, spiritual, and constitutional notice that the Crown of Judah Tribal Nation of Yashar'el, operating under its ratified Tribal Trust Charter, stands entirely separate from the legislative, judicial, and commercial jurisdiction of the United States, its subsidiaries, and any state, county, or corporate government entity—except by formal, mutual treaty or agreement.

We assert and affirm that no contract, statute, or assumption may override our spiritual inheritance, tribal lineage, and lawful Indigenous sovereignty under divine law and international recognition.

II. Constitutional and Statutory Foundation

- U.S. Constitution – Article I, Section 2:
“...excluding *Indians not taxed*...” affirms that Indigenous people not subject to taxation are also not subject to federal legislative apportionment or general jurisdiction.
 - United States Census Instructions (1860, 1880):
Indians living in tribal relations and not taxed shall not be counted within the United States for federal purposes—affirming their distinct political status.
 - 26 U.S. Code § 7701 and § 6675:
Tribal Nations are not classified as “persons” under federal revenue definitions and therefore are not liable under U.S. taxation statutes unless specifically waived.
 - Indians Not Taxed Doctrine:
The phrase “Indians not taxed” refers to sovereign tribal peoples who are not under federal jurisdiction, and therefore not subject to direct taxation, regulation, or compulsory participation in government programs.

III. Supporting U.S. Supreme Court Case Law

- *Kiowa Tribe v. Manufacturing Techs., Inc.*, 523 U.S. 751 (1998):
Tribal sovereign immunity applies even to off-reservation activity unless clearly waived.
 - *Oklahoma Tax Comm'n v. Potawatomi Indian Tribe*, 498 U.S. 505 (1991):
Sovereign immunity shields tribal governments from taxation or legal action without consent.
 - *Santa Clara Pueblo v. Martinez*, 436 U.S. 49 (1978):
Internal tribal matters are immune from federal review.
 - *United States v. Anderson*, 625 F.2d 910 (9th Cir. 1980):
Ambiguities in law must be resolved in favor of the tribe.
 - *Choate v. Trapp*, 224 U.S. 665 (1912):
Tax exemptions granted to Indians must be honored unless explicitly revoked by Congress.

IV. Indigenous & Ecclesiastical Standing

The Crown of Judah Tribal Nation is an Indigenous, spiritual, and ecclesiastical body governed by:

- Torah (Divine Law)
- Natural Law
- Customary International Law
- UNDRIP Articles 3, 4, 5, 33, and 37

We are not “U.S. persons”, not corporate entities, and not beneficiaries of federal grants or waivers. Our people are of bloodline descent, and our sovereignty is inherited, not bestowed.

V. Scriptural Authority for Separation

“Come out of her, My people, that ye be not partakers of her sins...”
— *Revelation 18:4*

“For Yahuah’s portion is His people; Jacob is the lot of His inheritance.”
— *Deuteronomy 32:9*

“The children of Yashar’el shall dwell every man under his vine and under his fig tree; and none shall make them afraid.”
— *Micah 4:4*

VI. Final Affirmation

We do not contract with the Internal Revenue Service, the Social Security Administration, the United States Department of Transportation, or any corporate agency of foreign jurisdiction, unless by treaty or lawful agreement.

This declaration affirms that:

- Our Nation is not subject to the jurisdiction of the United States under the 14th Amendment.
- We are foreign nationals of Indigenous ecclesiastical status, governed by our own laws and customs.
- All tribal members are protected under international and divine law, and we explicitly reserve all rights, titles, and jurisdictions.
