#### CROWN OF JUDAH TRIBAL NATION OF YASHAR'EL

Through the Matriarchy of all life, we, born as clans, to become tribes, and now, A Nation of tribes herein.

## Preamble

We, the People of the CROWN OF JUDAH TRIBAL NATION OF YASHAR'EL (COJ), here and now,

lay down in writing, the laws and way of life, for the historically established nation of people through ancestral lineage, to provide general welfare,

conserve and re-develop our lands and resources, to provide common defense and protections for ourselves and our posterity, to resecure our way of life, structures and immunities pre-established at the onset of

Creation of all, that we are indeed the true people, the original people and, the real people of the Erets (earth), with rights bestowed by The Great Spirit, and are now standing up to reclaim and reestablish that which was stolen and disguised but now revealed through the love of The Great Spirit.

We, the sovereign Indigenous tribes and nations of the Americas, the Pacific and of Africa, united by our shared heritage and mutual recognition of sovereignty, do hereby establish this Constitution to provide a comprehensive framework for social, economic, environmental, and political sustainability. This Constitution is founded upon the principles of cultural preservation, economic empowerment, and the protection of sovereign rights while fostering global collaboration and collective prosperity for present and future generations.

#### **Article I: Foundational Principles**

#### **Section 1: Sovereignty**

Each member tribe of COJ retains its inherent autonomy and self-determination, with the authority to govern its cultural, economic, and political affairs without external interference. COJ serves as an advocate and facilitator, supporting the independence and self-governance of its members while respecting their unique traditions, governance structures, and resource management practices.

#### **Section 2: Cultural Preservation**

COJ is committed to the protection, promotion, and preservation of Indigenous traditions, languages, sacred sites, ceremonies, and intellectual property. Through its Cultural Preservation Department, COJ facilitates intertribal unity by organizing cultural exchanges and educational initiatives that honor and safeguard Indigenous heritage.

#### **Section 3: Economic Empowerment**

To promote financial stability and growth among member tribes, COJ shall establish sustainable trade agreements and cooperative economic ventures. Mechanisms such as the Tribal Prosperity Fund and Tribal Land Bank shall ensure equitable financial opportunities, resource-sharing, and economic sustainability.

#### **Article II: Governance Structure**

The governance structure of COJ comprises the Central Transnational Council (CTC), the Executive

Leadership, and the Tribal Arbitration Panel (TAP). The CTC serves as the legislative body, while the Executive Leadership manages operations, and the TAP ensures judicial oversight.

#### **Article III: Membership**

Membership in COJ is open to all sovereign Indigenous tribes within the Americas and Pacific Islands. Fees and financial contributions shall be determined by the Central Transnational Council and reviewed periodically to ensure equitable contribution and sustainability.

#### **Article IV: COJ Departments**

COJ departments focus on areas such as tribal registry, economic development, legal advocacy, and cultural preservation. Each department shall work collaboratively to advance the interests of member tribes.

#### **Article V: Economic Alliance**

The Global Indigenous Trade Network (GITN) shall facilitate economic collaborations while ensuring that land usage and investment adhere to tribal laws and sustainable development principles.

#### **Article VI: Political Collaboration**

COJ shall provide a unified voice for Indigenous rights in global forums, ensuring representation, advocacy for treaties, and strategic partnerships.

#### **Article VII: Dispute Resolution**

Disputes arising within COJ shall be resolved by the Tribal Arbitration Panel (TAP) within a transparent and timely process, with appeals escalated to the CTC when necessary.

#### **Article VIII: Amendments**

Amendments to this Constitution require a two-thirds majority vote of the CTC, following consultation with member tribes during the review phase.

#### **Article IX: Dissolution**

The dissolution of COJ requires unanimous consent from the founding tribes. Upon dissolution, all assets shall be equitably distributed, and liabilities addressed responsibly.

#### **Article X: Implementation**

This Constitution becomes effective upon ratification by a two-thirds majority of the CTC, ensuring fair and transparent application of all provisions.

#### **Article XI: Federal Relationship**

The CROWN OF JUDAH TRIBAL NATION OF YASHAR'EL affirms its sovereignty in accordance with the December 26, 1933, Montevideo Convention's Rights and Duties of States in Montevideo, Uruguay, and memorialized in international law and the Good Neighbor Policy.

#### Section 1.

The CROWN OF JUDAH TRIBAL NATION OF YASHAR'EL reserves its full sovereignty to exercise its rights to enter mutually beneficial relationship with the Governments of North, South and Central America, and other relevant foreign nation-states, and organizations.

#### Section 2.

The Tribes of CROWN OF JUDAH TRIBAL NATION OF YASHAR'EL possess its own territory; own population; own branches of government (executive, legislative and judicial); and a veritable capacity to enter Treaties with other sovereigns and nation states.

#### Section 3.

The CROWN OF JUDAH TRIBAL NATION OF YASHAR'EL is a sovereign government organization of sovereign tribes that operate apart from foreign states or governments. The CROWN OF JUDAH TRIBAL NATION OF YASHAR'EL possess inalienable powers of sovereignty; possess the authority to

govern its people and territories. The CROWN OF JUDAH TRIBAL NATION OF YASHAR'EL retain the rights of an independent sovereign nation apart from the local, state or foreign government. The CROWN OF JUDAH TRIBAL NATION OF YASHAR'EL government retain its sovereignty of cultural heritage and identity.

#### **Article XII: – JUDICIAL POWER**

The judicial branch consists of the CROWN OF JUDAH TRIBAL NATION OF YASHAR'EL (COJ) i.e., International Court of Tribal Justice. The judicial Power of the Crown of Judah Tribal Nation of Yashar'el is guided by COJ International Court of Tribal Justice.

**Section 1. Creation.** The judicial power of the CROWN OF JUDAH TRIBAL NATION OF YASHAR'EL shall be vested in the CONGRESS of COJ and in COJ International Court of Tribal Justice courts established by the CONGRESS of COJ. The COJ International Court of Tribal Justice and inferior courts shall be independent from the CONGRESS of COJ whereby courts in other locations that have been established or will be established shall have their own local Chief Justice for the handling of judicial affairs, and other court matters, and no elected official or council member exercising powers of the CONGRESS of COJ will be able to exercise powers vested in the COJ International Court of Tribal Justice.

**Section 2. Jurisdiction**. The judicial power shall extend to all cases, in law and equity, arising under the Constitution of the CROWN OF JUDAH TRIBAL NATION OF YASHAR'EL; the Laws of the CROWN OF

JUDAH TRIBAL NATION OF YASHAR'EL, or for all members and property within the jurisdiction of the CROWN OF JUDAH TRIBAL NATION OF YASHAR'EL.

**Section 3. Powers of the COJ International Court of Tribal Justice.** The COJ International Court of Tribal Justice shall exercise the following powers:

- (a) The COJ International Court of Tribal Justice shall have appellate jurisdiction over any case on appeal from inferior tribal courts.
- (b) The COJ International Court of Tribal Justice shall have the power to declare laws of the CROWN OF JUDAH TRIBAL NATION OF YASHAR'EL void if such laws are not in agreement of the CROWN OF JUDAH TRIBAL NATION OF YASHAR'EL Constitution. All decisions of the COJ International Court of Tribal Justice and Chief Decider, Judge shall be in writing and shall be final by written order.
- (c) Commissioner of the COJ International Court of Tribal Justice must have a minimum age of twenty-eight (28) years of age or older, have no past or present criminal (true crime) history or felonies, have had at least three years courtroom experience attendant of courts, lawful and legal studies, international law, American Indian laws and Spiritual laws.

- (d) Commissioner of the COJ International Court of Tribal Justice shall be appointed by the CONGRESS of COJ and Commissioner of the Office of Tribal Justice and Legal Affairs shall serve a ten (10) year term. The judges of inferior courts shall be elected at large by members of the CROWN OF JUDAH TRIBAL NATION OF YASHAR'EL under ordinances promulgated by the CONGRESS of COJ and shall serve a four (4) year term. In the event of a judicial vacancy due to death, resignation, or removal from said office, any successor duly appointed and confirmed shall only serve the balance of the term of the vacancy being filled.
- (e) There will be seven (7) seats on the COJ International Court of Tribal Justice all of whom must be members of the CROWN OF JUDAH TRIBAL NATION OF YASHAR'EL.
- (f) Powers of the COJ International Court of Tribal Justice, including the Commissioner, must be established within 6 months of the establishment of this Constitution, with Amendments made accordingly herein.
- (g) The Commissioner of the COJ International Court of Tribal Justice shall employ an Administrator, who shall have general administrative duties in the judicial branch. The COJ International Court of Tribal Justice shall have supervisory authority over the Administrator.
- **Section 4. Powers of the Inferior Tribal Court.** The inferior tribal court shall exercise the following powers: (a) Inferior tribal courts shall have power and be the place where complaints are heard and where a Commissioner of Justice makes findings of fact and conclusions of law and shall have the authority and power to make findings of fact and conclusions of law and shall have the authority and power to issue all remedies in law and in equity including injunctive and declaratory relief and all writs including attachment, prohibition, and mandamus.
- **Section 5. Compensation**. The CONGRESS of COJ shall have the power to establish the level of compensation for legal staff and appointees shall be established by Commissioner of the Office of Tribal Justice and Legal Affairs. The compensation to be received shall not be diminished during their continuance in office, but shall receive no other fee, gratuity, or perquisite of office, nor hold any other position of title, trust, or profit within the CROWN OF JUDAH TRIBAL NATION OF YASHAR'EL or any entity thereof, either directly or indirectly.

## Section 6. Removal. The CONGRESS of COJ may remove any Judge of the CROWN OF JUDAH NATION tribal courts by a two-thirds vote for:

- (a) Willful neglect of duty.
- (b) Unethical judicial conduct.
- (c) Physical or mental disability which prevent the performance of judicial duties.
- (d) Persistent failure to perform judicial duties.

- (€) Dishonest actions and purposeful dissemination of misinformation.
- (f) Gross misconduct that is clearly prejudicial to the administration of justice.
- (g) Habitual drunkenness.
- (h) Incompetency.
- (i) Any conviction of a felony, a crime under the laws of the CROWN OF JUDAH NATION that if committed in some other jurisdiction would also be a felony.
- (j) Any misdemeanor that is involving the moral turpitude, in bad faith, or offenses against CROWN OF JUDAH NATION committed while in office.

**Section 7. Vacancies.** If there is any vacancy or abandonment, CONGRESS of COJ and the Commissioner of the COJ International Court of Tribal Justice shall appoint a new replacement.

**Section 8.** The COJ International Court of Tribal Justice, at the request of its Partners in Peace and Prosperity, shall initiate a campaign which assert and claim just indigenous sovereign tribal rights as the original first people and permanent landowners of the Americas, and pursue Tribal Court remedy on behalf of Treaty Partners. A Tribal Court judgment shall be memorialized if there's no response as it is superior to any court judgement. Judgement collection shall be the responsibility of the individual Treaty Partner nation.

Section 9. The office of the Attorney General shall be a member of the CROWN OF JUDAH TRIBAL NATION OF YASHAR'EL and adept at Tribal Law and International Law engagement and defense; possessing the qualifications as found per Section 3. The Attorney General shall represent the CROWN OF JUDAH TRIBAL NATION OF YASHAR'EL in all criminal cases in the courts of the Nation, and in all civil actions wherein the CROWN OF JUDAH TRIBAL NATION OF YASHAR'EL is named as a party and shall have such other duties as the CONGRESS of COJ and the Commissioner of the COJ International Court of Tribal Justice may prescribe by law. The Attorney General shall be appointed by the National Chief and deputy Chief of the CROWN OF JUDAH TRIBAL NATION OF YASHAR'EL and confirmed by the CONGRESS of COJ for the term of five (10) years.

Section 10. The office of the Marshal shall be a member of the CROWN OF JUDAH TRIBAL NATION OF YASHAR'EL and with excellent tactical training and superior experience in law enforcement and security. The duties and authority of the Marshal shall be prescribed by law; to secure all resources – marine, wildlife, mineral and agricultural that belong to the CROWN OF JUDAH TRIBAL NATION OF YASHAR'EL prior to European contact and which is still owned by tribes – above and below their lands and soils. The Marshal shall be authorized to deputize such officers as necessary to carry out the law enforcement duties; secure police power and economic and political independence for the CROWN OF JUDAH TRIBAL NATION OF YASHAR'EL. The Marshal shall be appointed by the Commissioner of Policy and Law and be confirmed by the Council for a term of five (5) years.

#### Article XIII: - DISTRICT ORGANIZATION

Should districts be established, each district established under this Constitution shall have a Village CHIEF and Local District CONGRESS of COJ and liaison to CROWN OF JUDAH TRIBAL NATION OF YASHAR'EL CONGRESS of COJ, and such other officers as may be advisable to run concurrent with the terms of the representatives to the

CROWN OF JUDAH TRIBAL NATION OF YASHAR'EL CONGRESS of COJ.

Section 1. District CHIEF and Local District CONGRESS of COJ shall call and preside over councils of the district whenever necessary for the consideration of matters of local interest. The various districts may consult with District CHIEF and Local District CONGRESS of COJ on all matters of local interest, and District CHIEF and Local District CONGRESS of COJ may undertake and manage local enterprises in furtherance of the purposes set forth in the preamble to this Constitution, use monies or assets in treasury and under Trust for the benefit of the Tribe and Tribal member in each district upon CROWN OF JUDAH TRIBAL NATION OF YASHAR'EL CONGRESS of COJ approval, keep a roll of those member of the Tribe affiliated with each district, and may exercise such further powers as may be delegated to districts by the District CHIEF and local district council. The actions of the District CHIEF and local district councils shall not be inconsistent with the Constitution and by-laws, and ordinances of the CROWN OF JUDAH TRIBAL NATION OF YASHAR'EL.

Section 2. The Council shall establish representative districts which shall be within the territories, boundaries and jurisdiction of the CROWN OF JUDAH TRIBAL NATION OF YASHAR'EL. The Council members representing districts within the boundaries must be domiciled within their district; the Village CHIEF and Local District CONGRESS of COJ and liaison shall be domicile within their district jurisdiction.

Section 3. The Council shall have the power to establish laws which it shall deem necessary and proper for the good of the CROWN OF JUDAH TRIBAL NATION OF YASHAR'EL, not contrary to the provisions of this Constitution. The style of all bills shall be: "Be It Enacted by The CROWN OF JUDAH TRIBAL NATION OF YASHAR'EL". The style of all resolutions shall be "Be It Resolved by The CROWN OF JUDAH TRIBAL NATION OF YASHAR'EL".

#### **Article XIV:- TREASURY**

The Chief of Treasury Department shall be the custodian of all funds, which come under the jurisdiction or control of the CROWN OF JUDAH TRIBAL NATION OF YASHAR'EL.

**Section 1.** The Chief of Treasury Department shall pay out funds in accordance with the laws established by the CONGRESS of COJ, shall keep accounts of all receipts and disbursements, and shall make written reports to the CONGRESS of COJ at each Regular and Special meeting. The Chief of Treasury Department shall be bonded in such an amount as the CONGRESS of COJ shall provide.

- **Section 2.** The Chief of Treasury Department shall make every effort to use gold and silver as a store of value, a medium of exchange, and as money on account. Where applicable and when convenient, the Chief of Treasury Department shall utilize Federal Reserve Notes (paper money) to transact in commerce.
- **Section 3.** The Chief of Treasury Department shall make every effort to create educational materials for training about 'commerce' and 'gold as real money' and other relevant medium of exchange for the benefit of the CROWN OF JUDAH TRIBAL NATION OF YASHAR'EL and its members.
- **Section 4.** The Chief of Treasury Department shall make every effort to utilize a Lawful Money "Monetary System" Structure to include Gold, Silver, and various precious metals as the medium of exchange.
- **Section 5.** The Chief of Treasury Department shall make every effort to leverage unincumbered UNITED AMERICAN TRIBAL EMBASSY INTERNATIONAL assets, never placing said assets in jeopardy via shortterm and log-term contract trades, for the economic benefit and prosperity of the CROWN OF JUDAH TRIBAL NATION OF YASHAR'EL and its members.
- **Section 6**. The Chief of Treasury Department shall make every effort to develop the CROWN OF JUDAH TRIBAL NATION OF YASHAR'EL's platform for the economic benefit and prosperity of the CROWN OF JUDAH TRIBAL NATION OF YASHAR'EL and its members.

#### **Article XV: – GOVERNANCE**

- **Section 1.** The CROWN OF JUDAH TRIBAL NATION OF YASHAR'EL tribal governments aims to be a haven for all; a Nation tribal government with the aims to govern with full transparency. As a progressive Nation, the tribal government shall initiate and facilitate the following initiatives: building and developing infrastructure systems, including roads, public buildings, water, electricity, and telecommunications structure to benefit its people and their communities. Social programs such as education, workforce development, healthcare, land management and others shall also be successfully initiated. The CROWN OF JUDAH TRIBAL NATION OF YASHAR'EL tribal governments also aims to provide these following services: police power; police departments; first-responder services and court systems to protect its members and maintain law and order.
- **Section 2.** All Debts contracted and Engagements entered, before the Adoption of this Constitution, shall be as valid against the Crown of Judah Tribal Nation of Yashar'el under this Constitution, as was without a constitution. This Constitution, and the Laws of the Crown of Judah Tribal Nation of Yashar'el which shall be made in Pursuance thereof; and all Treaties made, or which shall be made, under the Authority of the Crown of Judah Tribal Nation of Yashar'el, shall be the supreme Law of the Land; and the Justice Commissioners of every COJ territory shall be bound thereby.
- **Section 3.** The CONGRESS of COJ before mentioned, and the Members of all Commissions, and all executive and judicial Officers, of the Crown of Judah Tribal Nation of Yashar'el, shall be bound by Oath or Affirmation, to support this Constitution under Flag and Seal adopted by the people of the Earth,

flushed with the blood of Abya Yala; where no soul of the Crown of Judah Tribal Nation of Yashar'el will ever be denied 'Aboha (Beyt) (dwelling).

**Section 4.** The Ratification of the Conventions of the twenty-six (26) Founding Chiefs of this new government of the Crown of Judah Tribal Nation of Yashar'el shall be sufficient for the Establishment of this Constitution between the tribes of the Caribbean, South America, North America, Central America and Africa so ratifying the Same.

A Convention by the Unanimous Consent of the registered tribes listed below, signed and Sealed in the year of universal alignment presented on this twenty second (3rd) day of January, in the year 2025, declaring the unification and independence the Crown of Judah Tribal Nation of Yashar'el of the Americas.

We, the People empowered with wisdom, do witness, whereby, We, the Founding Mothers and Fathers Of the Crown of Judah Tribal Nation of Yashar'el Congress have hereto subscribed our Names and SEALS under the SEAL,

OATH and FLAG of the Crown of Judah Tribal Nation of Yashar'el

Signed and Sealed this 3rd day of January 2025.
