

# DECLARATION OF NATIONHOOD AND SOVEREIGN INDIGENOUS STATUS

CROWN OF JUDAH TRIBAL NATION OF YASHAR'EL

## I. PREAMBLE

We, the **Crown of Judah Tribal Nation of Yashar'el**, a sovereign Indigenous, spiritual, and ancestral Nation, do hereby declare and proclaim our pre-existing nationhood, sacred right to self-governance, and autonomous standing among the nations of the Earth. Our authority stems not from man-made institutions, but from the divine order of **Yahuah**, the Supreme Creator, and from the bloodline inheritance of the ancient Tribes of Yashar'el, with direct lineage to the House of Judah.

We stand not as a product of colonial systems, but as a **reawakened sovereign Indigenous people** who predate all modern governments, including the United States and its subsidiaries. We affirm our spiritual, cultural, political, and territorial rights as a nation unto ourselves.

## II. LEGAL AND SPIRITUAL BASIS

### A. International Law

Under **international law**, our nationhood is protected and affirmed by the following:

- United Nations Declaration on the Rights of Indigenous Peoples (UNDRIP)**
  - Article 3*: Right to self-determination
  - Article 4*: Right to autonomy and self-government
  - Article 5*: Right to maintain distinct legal, political, and social institutions
  - Article 33*: Right to determine membership and identity
  - Article 36*: Right to maintain cross-border relations with related peoples
- Vienna Convention on Diplomatic Relations (1961)**
  - Right to maintain international representation and immunity as a foreign political body.
- International Covenant on Civil and Political Rights (ICCPR)**
  - Article 1*: All peoples have the right to self-determination.
- American Declaration on the Rights of Indigenous Peoples (OAS)**
  - Recognition of tribal governments, languages, lands, and sacred identity.

### *B. Treaty Rights*

We assert continuity through **pre-constitutional Indigenous treaties** including but not limited to:

- **Treaty of Hopewell (1786)** — affirming territorial integrity and peace with tribes in the Southeast.
- **Treaty of Fort Pitt (1778)** — the first written treaty between the U.S. and a sovereign Indigenous nation.
- **Natural Law Treaties** — those made among the tribes before European invasion, documented orally and spiritually.

We assert that we are not a newly-formed people, but the **reinstated legal successors and spiritual custodians** of our ancient nation.

### *C. Ecclesiastical and Natural Law*

Our rights are further affirmed by:

- **Divine law as expressed in Torah and ancient Scripture**
- **Natural law as acknowledged by the Law of Nations**
- **Ecclesiastical jurisdiction under spiritual authority**, recognizing that all governments are subordinate to the Most High and that man-made corporations have no rightful dominion over Yahuah's chosen nation.

## III. STRUCTURE AND GOVERNANCE

The Crown of Judah Tribal Nation of Yashar'el maintains:

- A **Tribal Constitution and Ecclesiastical Trust Charter**
- An operating **Embassy of Foreign Affairs**
- A **Council of Elders and Ministers**
- **National ID Cards**, tribal documentation, vehicle registration, land notices, and census operations.

Our government structure includes judicial, executive, legislative, and spiritual offices operated in alignment with divine order and Indigenous custom.

## IV. BORDERS AND TERRITORY

While forcibly displaced and colonized, the Crown of Judah Tribal Nation reclaims ancestral lands originally known as:

- Parts of **Mississippi, Alabama, Georgia, and the Gulf Territories**
- Ancient tribal land affiliated with the **Yazoo, Choctaw, Natchez, and Hebrew tribal bloodlines**
- All **spiritual lands** belonging to the House of Judah by divine inheritance, regardless of current political labels

We do not seek permission to exist within these lands—we **reaffirm our presence and stewardship under the Creator**.

## V. RELATIONSHIP TO THE UNITED STATES

We are **not U.S. citizens** by voluntary consent, but **foreign Indigenous nationals** as described in the U.S. Constitution:

- *“Indians not taxed”* — U.S. Constitution, Article I, Section 2
- We reject all presumptions of U.S. corporate jurisdiction over our people, land, and institutions.
- We assert **tribal sovereign immunity** and **non-participation in federal benefits systems**, except through lawful treaty engagement as a separate nation.

## VI. DECLARATION OF FOREIGN NATIONAL AND DIPLOMATIC STATUS

By this Declaration, we notify all nations, states, agencies, and global entities that:

- The **Crown of Judah Tribal Nation of Yashar’el** is an **active, lawful, and operating nation**.
- Our leaders, including **Ambassador Kabir elohim IsReal-Judah**, act under **diplomatic capacity** protected by international law.
- Our people are under divine jurisdiction and protected by both **customary international law and higher law**.

## VII. NOTICE TO THE WORLD

Let it be known:

1. We do not seek permission.
2. We **affirm** our status publicly and lawfully.
3. We offer peace, dignity, trade, and mutual recognition to all nations.

4. Any entity or government that violates our rights under color of law shall be held accountable under the law of nations and international tribunals.

## VIII. RECORD AND PUBLICATION

This Declaration shall be:

- Published online and in public record.
- Sent to the **U.N. Permanent Forum on Indigenous Issues, OAS, U.S. State Department**, and **relevant bodies**.
- Archived within the **Embassy of the Crown of Judah Tribal Nation**.
